1. Domain Name:

A domain name is that which is assigned to the customer by authorities outside the jurisdiction of **Golden Web Weaver**, whether customer is a corporation or flesh and blood, and remains entirely within ownership of said entity, the customer. Authorities outside the jurisdiction of Golden Web Weaver can be compared to organizations that register the Warranty Deed to real estate, or State Government authorities that register the title of a vehicle. A domain is often colloquially referred to as a “**DOT COM**” whatever the suffix such as “net,” “org,” etc.

Domain name will be, finally, decided upon by the **CUSTOMER**. However, advice from **Golden Web Weaver** will be forthcoming of the most beneficial domain names that are available.

Considering the recent increasing trend in the Web Design/hosting industry of retaining ownership by web designers and hosting services, **Golden Web Weaver** enters into this agreement with a promise to set up the domain, giving ownership to said **CUSTOMER**, while utilizing above mentioned “authorities outside the jurisdiction of **Golden Web Weaver**.”

If customer’s preferred domain was under their own control prior to this agreement, then permission is hereby given for hosting access to **Golden Web Weaver**, and domain pointers will be directed by **CUSTOMER** to ns1.goldenwebweaver.com and ns2.goldenwebweaver.com, or permission is hereby given for **Golden Web Weaver** to make that adjustment after correct **DOMAIN REGISTRATION SITE**, user name and password is passed on to **Golden Web Weaver**. While access may be given to **Golden Web Weaver** to change the content of the web site, and permission may be given by the **CUSTOMER** for **Golden Web Weaver** to set domain pointers, domain ownership and the right to change access of domain to **CUSTOMER** exclusively, or another entity, will always be retained by the **CUSTOMER**.

2. Hosting Service:

This can best be described, simply, as space and bandwidth on the internet. Access to such space and bandwidth allotment by **Golden Web Weaver** is separate from that of the domain name registration. Everyone who owns a **DOMAIN NAME** is much like a person or corporation renting space in an office complex, or apartment building. Pictures, videos, and text take up space. In addition, bandwidth is the amount of **USE**, or **ACCESS** taken by all computers worldwide that access, or **USE**, customer’s **DOMAIN** content.

So, time is a factor both for space (storage) and bandwidth.

Terms here are for one year, _____ GB storage, and _____ GB bandwidth per month. Considering the nature of your business or pleasure use, this allotment should be sufficient. If bandwidth **USE** is exceeded during a monthly period, website will automatically shut down until a

new bandwidth allotment is made, or a new monthly period begins. **Golden Web Weaver** will be notified immediately through electronic means by the computer that stores the customer’s data, and the customer will be notified by **Golden Web Weaver**. It is extremely unusual for bandwidth to exceed the initial allotment. Unusually high volumes are caused by extremely high, and unexpected, publicity that often brings unusually high profits for a business.

CUSTOMER has access to his or her own website to make adjustments at any time. Customer agrees to notify **Golden Web Weaver** immediately whenever customer makes modifications, and what files were modified.

After one year, the customer may continue to pay **Golden Web Weaver** for domain renewal, space and bandwidth, utilize a different company, or serve them self. However, the price after one year cannot be determined until that time comes, because of unpredictable rates of inflation.

3. Web Design:

Web Design is the service provided by **Golden Web Weaver**, consisting of conference with the **CUSTOMER**, taking still pictures, motion pictures, and notes about what should be included in the web design. It is the creativity and experience of **Golden Web Weaver** that is of value to the **CUSTOMER**, and that includes former positions in industry, as well as web design experience for various industries. Web design also consists of research, creating pages of text, editing text, editing and modifying videos, placing pictures, picture editing, copies of logos, and links to other sites. It may include services of e-mailing to clients of the **CUSTOMER** if such is specifed in this agreement..

4. Continuous Service:

Initial investment is for the set up of the domain and website, only. Changes after the setup **[(4) (and complete satisfaction of CUSTOMER)]** will be accomplished by negotiated payment for each separate adjustment, unless an additional yearly or monhly fee written agreement is made, and paid in advance.

[(4) 5. Guarantee of Satisfaction:]

Investment made covers a one year period. **[(4) then after investment the site must meet customer’s expressed approval before the work of Golden Web Weaver may be considered satisfactory, and complete,]** for the initial investment.

6. Aditonal Provision

No illegal activty will be aided by **Golden Web Weaver**, and no such content will be permitted to be held on the host compter. Customer agrees not to engage in any illegal activity. Any, and all, illegal content, or that which contains copyright infringements, will be removed by **Golden Web Weaver**, Repeat violations will be cause for the termination of this agreement, and hosting service.
